

**AEON SPECIALIZED BANK (CAMBODIA) PLC.**  
**“Monthly cashback up to USD3 spend at gas stations with AEON Card.”**  
**Terms and Conditions**

**Definitions:**

- The **Promotion** refers to “Monthly cashback up to USD3 spend at gas stations with AEON Card” organized by **AEON SPB** in accordance with the Terms and Conditions as herein stipulated.
- **AEON SPB** refers to “**AEON Specialized Bank (Cambodia) PLC.**”
- **Gas stations** refers to cooperate stations such as “**CALTEX and TOTALENERGIES Stations**” both in provincial and Phnom Penh that accepts AEON Card payment.
- **Eligible Cardholders** refers to all **AEON Cardholders** (including **AEON SPB’s** staffs) having AEON Card during the **Promotion Period** to make payment followed promotion’s condition excluding cardholders whose card accounts have been suspended, cancelled, or terminated for whatsoever reasons during the **Promotion Period**.

**Promotion Period:**

The **Promotion** is from **January 2026 to March 2026 (03 months)**, including public holidays or be extended to other periods determined at the sole discretion of **AEON SPB** without any prior notice.

**Promotion Conditions:**

- Eligible Transactions shall receive cashback on its respective transaction amount based on the transaction timestamp as recorded in **AEON SPB’s** system date and time (“**up to USD 3 Cashback**”).
- The Eligible Transactions mean transactions for the purchase of goods and services incurred for personal consumption, and **not for business purposes, excluding Eligible Transactions which are subsequently cancelled, disputed, refunded, unauthorized or fraudulent transactions.**
- Subject to the Terms and Conditions herein, all cardholders are required to use an AEON Card to perform transactions at participating Caltex and TotalEnergies stations that accept AEON Card payment (excluding AEON Card Mobile Scan to Pay), during the stations’ business hours.
- Transactions shall be accumulated monthly, meaning that all eligible transactions made each day within the same calendar month during the promotion period will be counted as ‘**Monthly Accumulated Spend.**’
- **Monthly Accumulated spend** shall follow table as shown below:

- The cashback offer will be credited into the principal cardholder account, **within 10 working days of the next following month.**

**AEON SPB** reserves the absolute right to **disqualify the participation of any Eligible Cardholders** for the purpose of this Campaign without having to alert him/her in the event:

- (a) the **Eligible Cardholder's** Card account is in default (the detail of "Default" please click the link ([TCs-AEON-Card-ENG](#) & [TCs-AEON-Card-KH](#)) during the **Promotion Period**; or
- (b) the Eligible Cardholder's Card account is closed during the **Promotion Period**; or
- (c) the Eligible Cardholder has provided untrue information or acted fraudulently in any manner during the **Promotion Period**; or
- (d) the Eligible Cardholder breaches any of these Terms and Conditions stipulated herein.

**Liability:**
