

## AEON SPECIALIZED BANK (CAMBODIA) PLC.

### “Get up to \$20 cashback at Baby Care Stores with AEON Card.”

#### Terms and Conditions

##### Definition:

- **The Campaign** refers to get up to \$20 cashback at Baby Care Stores with AEON Card organized by **AEON SPB** in accordance with the Terms and Conditions as herein stipulated.
- **AEON SPB** refers to **AEON SPECIALIZED BANK (CAMBODIA) PLC.**
- **Participant Merchant** refers to Baby Care Stores that accepted AEON Card payment.
- **Eligible Cardholders** refers to customers of **AEON SPB** including **AEON SPB's** staff having AEON Card and making payment during the **Campaign Period** at Participation Merchant excluding Cardholders whose Card accounts have been suspended, cancelled, or terminated for whatsoever reasons during the **Campaign Period**.

##### Campaign Period:

- The Campaign is from 01<sup>st</sup> May 2024 to 31<sup>st</sup> July 2024, both dates inclusive (“**Campaign Period**”) or such other period(s) as may be determined at the sole and absolute discretion of **AEON SPB** without prior notice.
- Eligible cardholder transactions shall be made every day during **Campaign Period**

##### Eligible Transaction:

- Eligible Transactions shall receive cashback on its respective transaction amount based on the transaction timestamp as recorded in **AEON SPB's** system date and time (“**up to \$20 Cashback**”).
- The Eligible Transactions mean transactions for the purchase of goods and services incurred for personal consumption, and **not for business purposes, excluding Eligible Transactions which are subsequently cancelled, disputed, refunded, unauthorized or fraudulent transactions.**
- Subject to the Terms and Conditions hereinafter appearing, all Participants are required to use AEON Card to perform transactions at all participated Baby Care Stores accepted AEON Card Payment following the store business hours.
- An eligible transaction for cashback shall be based on Merchant name, Baby Care Stores.
- Participant transactions shall be accumulated monthly meaning that every transaction of each month during the campaign period.

## Remark:
